Installation Instructions for Aztec Trainer© Fired Heater Simulator

Following are the steps required for installation of the software.

1. Read the following licensing agreement. If you choose to agree with the terms of the licensing agreement then proceed. If you choose not to, or cannot, abide by the agreement, cease the installation process and contact Aztec Engineering with any applicable questions.
2. Obtain a user name and a password by purchasing the software or applying for a free limited time demonstration license <http://www.aztecengineering.com/32901.html>.
3. Obtain a key (license) file by completing the form in step 1 above or providing Aztec Engineering LLC the volume serial number for the computer drive on which the simulator will be installed. <http://www.aztecengineering.com/Vol Serial Number.html>.
4. If a previous version of Trainer has been installed on your system, it is recommended that you remove it before proceeding with the installation.
5. Direct your browser to <http://www.aztecengineering.com>, click "Downloads", click "Trainer© (Beta 1-4)" and enter the username and the password. Download Trainer.msi
6. Begin the installation by "clicking" the Trainer.msi icon.
7. Copy the Trainer.key file into your installation directory (most likely "c:\ProgramFiles\Trainer").
8. The installation should be complete.
9. It is recommended you delete Trainer(beta1-4).msi to avoid confusion with future versions of Trainer.
10. To start Trainer, go to the programs menu and "click" Aztec Programs.

******BEGIN LICENSING AGREEMENT******

IMPORTANT-READ CAREFULLY

This Aztec Engineering End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and Aztec Engineering, L.L.C. ("Aztec") for the Aztec software product identified above, which includes computer software and may include associated media, printed materials, and "online" or electronic documentation (collectively, "SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. If you do not agree to the terms of this EULA, you may not use the SOFTWARE PRODUCT.

SOFTWARE PRODUCT LICENSE

Copyright laws and international copyright treaties, as well as other intellectual property laws and treaties protect the SOFTWARE PRODUCT. The SOFTWARE PRODUCT is licensed, not sold.

INTRODUCTION

The SOFTWARE PRODUCT is comprised of the following components: (i) Executable programs, (ii) .DLL files, (iii) web pages and (iv) images produced by Aztec Engineering. English shall be deemed the language that controls the terms of this EULA.

This EULA describes your rights with respect to the SOFTWARE PRODUCT and its components.

1. GRANT OF LICENSE. This EULA grants you the following rights:

** Standard Use. You may install and use one (1) copy of the SOFTWARE PRODUCT on a single computer, unless network licenses are granted in which case multiple copies of the software may be used up at a single site to the limit DETERMINED IN WRITING between Aztec and the user.*

** Development Use. No development use is allowed under any circumstances unless expressly permitted by Aztec. This includes any dynamic link libraries (.DLL files) and ActiveX controls contained within the SOFTWARE PRODUCT.*

2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.

** Support Services. Aztec may provide you with support services related to the SOFTWARE PRODUCT ("Support Services"). Use of Support Services is governed by the Aztec policies and programs described in the user manual, in "on line" documentation and/or other Aztec-provided materials. Any supplemental software code provided to you as part of the Support Services shall be considered part of the SOFTWARE PRODUCT and subject to the terms and conditions of this EULA. With respect to technical information you provide to Aztec as part of the Support Services, Aztec may use such information for its business purposes, including for product support and development. Aztec may utilize such technical information in a form that personally identifies you.*

** Limitations on Reverse Engineering, Decompilation, and Disassembly. You may not reverse engineer, decompile, or disassemble the SOFTWARE PRODUCT.*

** Rental. You may not rent, lease or lend the SOFTWARE PRODUCT.*

** Software Transfer. Licenses for the SOFTWARE PRODUCT are non-transferable.*

4. TERMINATION.
